Consideration will be given only to Contractors who submit evidence that they are properly licensed as required by Chapter 87 of the North Carolina General Statutes to bid and perform the work described herein as the general contractor and must have proper licenses under the state laws governing their respective trades at the time of the bid opening. The City reserves the right to waive any informalities in the bidding and to reject any or all bid proposals.
