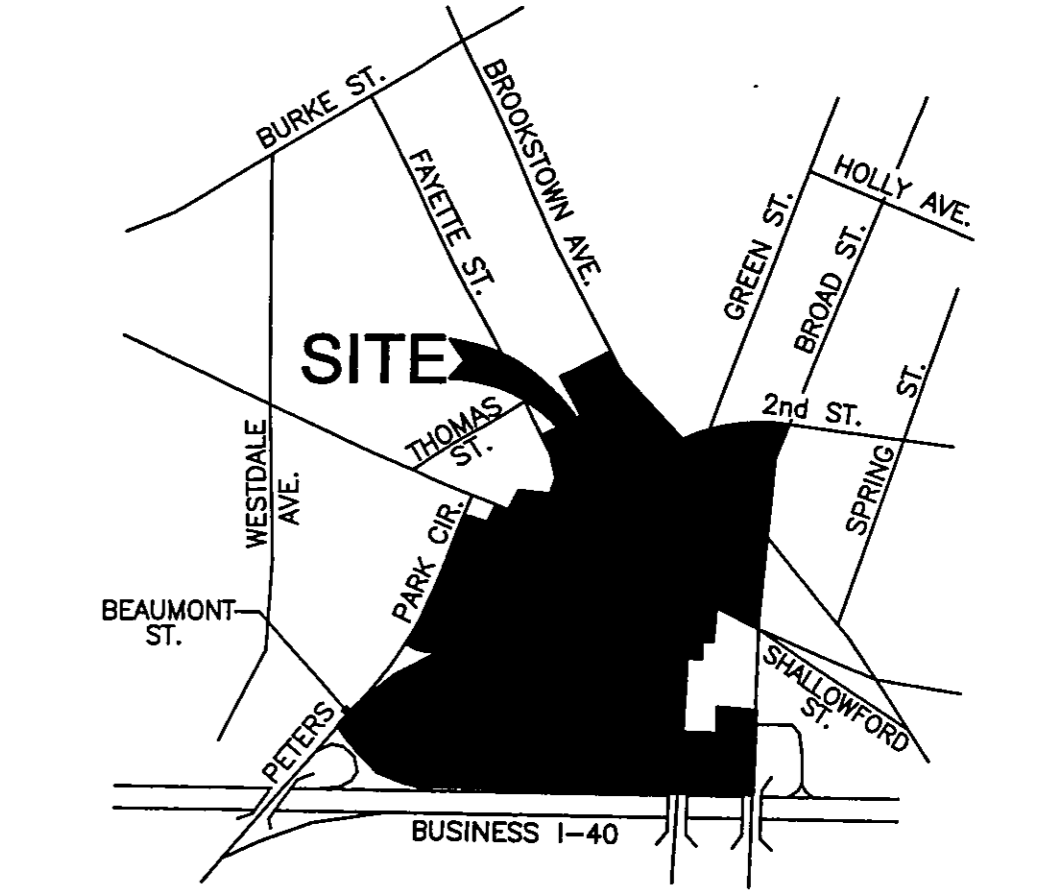


LOCATION MAP: NOT TO SCALE

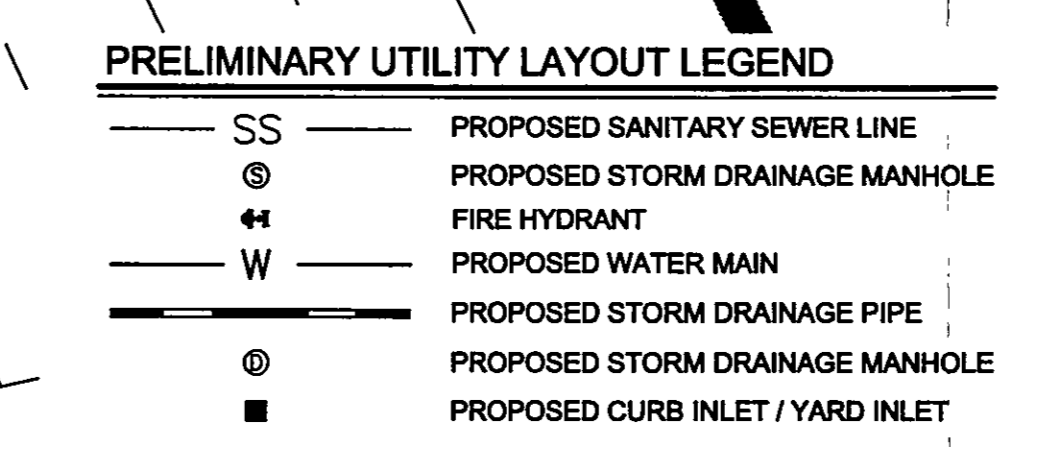
