The Utility Commission authorized the execution of various agreements regarding proposed water and/or sanitary sewer improvements to be installed within various developments. The total estimated cost of all water improvements is \$238,890 and sewer improvements is \$493,970.

The Utility Commission approved **Robinson Fans, Inc.** as a sole-source vendor for specialty parts for the Biosolids Drying Facility in the amount of \$111,106.

The Utility Commission authorized acquisition of two easements by deed in the amount of \$48,425 for the **Machine Street Pump Station Project.**

The Utility Commission approved an agreement with **Black and Veatch International Company** to provide upgrades to the Muddy Creek and Archie Elledge Wastewater Treatment Plants in the amount not-to-exceed fee of \$2,950,000.

The Utility Commission authorized acquisition of nine easements by deed or condemnation in the amount of \$26,275 for the **Reynolds Creek Outfall Improvements Project.**

The Utility Commission authorized the execution of an engineering agreement in the amount of \$399,690/00 with **Hazen and Sawyer**, **P.C.** to perform design, bidding and construction administration services for upgrades to chemical systems at **Elledge and Muddy Creek Wastewater Treatment Plants**.

The Utility Commission authorized acquisition of three easements by deed in the amount of \$300 for the **Brushy Branch Outfall Replacement Project.**

The Utility Commission authorized the execution of a Three Party Funding and Reimbursement Agreement with Whitaker Park Development Authority, Inc. and Forsyth County to construct Water and Sewer Improvements at Whitaker Park.

The Utility Commission authorized sole-source equipment procurement from **Tencarva Machinery Company** for the Tanglewood Lift Station in the amount \$49,623.00.
