

TYPES OF PERMITS & INFORMATION

SOLICITATION PERMIT	BASM Bldg.	Revenue Department Gil Rush -747-7484	Permit is for Citizen's that would like to stand and solicit for work and/or funds throughout the City
SOLICITATION PERMIT (Non-Profit)	City Hall	City Clerks' Office	Permit issued for Non-Profit solicitation for donations (example - Kids standing out in median requesting donations)
PICKETING PERMIT	Public Safety Bldg.	WSPD Bruce Daniel - 306-9362	Protest or Picket against an issue
OPEN AIR PERMIT	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Public meetings on a public street, sidewalk, alley or mall within the City of Winston- Salem
FOOT PEDDLER	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Person selling on foot, i.e. balloons, pennants, tickets, newspapers, flowers, fragrances, candles, etc.
PEDDLER ON FOOT (Door to Door)	BASM Bldg.	Revenue Department Gil Rush -747-7484	Person vending in residential neighborhoods going door to door to sale their product (vacuum cleaners, insurance, alarm systems, etc.)
PUSHCART	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Person using rubber-wheeled vehicle or portable cart for the sale of food products, drinks, etc. i.e. hotdogs, link sausage, burgers, etc.
STREET PERFORMERS/ BUSKERS	City Hall	Business Inclusion & Advancement Hannah Hernandez -734-1251	Person or persons performing audible or visual entertainment, i.e. reciting, singing, acting, dancing, miming, musical instruments (not amplified), etc.
PYROTECHNICS	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Fireworks
SIDEWALK CAFÉ DINING	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Outside seating for dining at restaurants and bars
SOUND PERMIT	City Hall	Business Inclusion & Advancement Hannah Hernandez - 734-1251	Sound Permits are issued "ONLY" for Special Events during a Race, Run, Parade, Festival, and Block Party on City Property. Private residential parties are not required to obtain a sound permit.
SPECIAL EVENT PERMITS Race, Run, Parade, Festival, Filming or Block Party	City Hall	Business Inclusion & Advancement Hannah Hernandez -734-1251	When a person requests to block off or close street(s) to have a race, run, parade, festival, block party or filming
